Just because you retired from the plant doesn't mean you are retired from your union. As a union veteran you understand the power of membership. You know what it means to fight for a better living, to have your voice heard, and to stand as one. You can continue to fight in your retirement years by joining or forming a retiree club.

IUE-CWA Retiree Clubs enable you to keep in touch with other retired coworkers and to be educated on the issues. During a meeting you can hear and learn about state and national legislation that affect retirees and seniors. Often, guest speakers are invited to talk about specific topics such as Medicare, Social Security, Senior Law, Veteran Freedom Flights, Veteran's Administration, etc. You can choose how much you want to participate, but by being a club member you will get the communications you need to stay on top of the issues that concern you most. From organized social trips to political action – you can have the scoop on what is going on, just like when you were an active member.

If there is no retiree club nearby, you can still support your union by becoming a Retired Associate Member of the IUE-CWA.

For \$36 per year you will be supporting the IUE-CWA as it continues to fight proposed laws and legislation that negatively affect IUE-CWA Retirees. We will continue to let you know of potential political candidates who we have vetted and who will fight on behalf of our retirees. You will also receive our quarterly newspaper, "The Bolt," and in it will be informative articles for retirees. This support costs you about \$.10 a day. Ten Cents a day is not that much, as the IUE-CWA still fights for its retirees.
